Headings (9, bold)

The headings and subheadings from introduction to Acknowledgement must be in 9 points, bold face, aligned left, don't underline any words in your paper, subheadings are numbered with 1, 2, 3 etc, delete and type).

Conclusion

A conclusion must include advantages, limitations, and applications and don't repeat the abstract, delete and type)

Arabic section:

(9 points, delete and type, you must translate in Arabic language the following: title, authors' names, abstract, keywords)

Abbreviations and Acronyms

Appear after Arabic section, you MUST define in full name all your abbreviations at the first time used, even if you have already used it in abstract. Do not abbreviation in title, do not use space between the abbreviations such as C. D. S., but use CDS.

Appendix

Appear before acknowledgment section if needed.

Acknowledgment

Appear after appendix, you MUST define in full name all your abbreviations at the first




Fig. 1: Title of figure
